SAN MATEO CROSSING CLOSURE NOTICE | March, 2022

UPCOMING ACTIVITIES AND CLOSURES

From March 14 to April 2, Caltrain will be performing signal cutover work at 17 grade crossings in Burlingame and San Mateo. Caltrain will perform grade crossing cutover and installation work in **San Mateo** that will require the temporary closures of the 2nd Avenue, 5th Avenue, and Villa Terrace railroad crossings to vehicle and bicycle traffic.

NOTE: Crossing gates will not be activated at all railroad crossings San Mateo and Burlingame during this time, but flaggers will be present to direct traffic through all other intersections.

SAN MATEO-TEMPORARY CROSSING CLOSURES

2nd Avenue, 5th Avenue, and Villa Terrace railroad crossings:

- **Saturday, March 19th at 12:01 a.m. to Sunday, March 20th at 8 a.m.**
- **Saturday, March 26th at 12:01 a.m. to Sunday, March 27th at 8 a.m.**

SAN MATEO-TENTATIVE CROSSING CLOSURES

2nd Avenue, 5th Avenue, and Villa Terrace crossings:

Between March 27th to April 2nd, testing will occur that COULD result in additional closures. Please watch for traffic signs and flagging staff.

CALTRAIN SERVICE INFORMATION

Temporary service changes in the weekday morning and late afternoon schedules (5:30-9 am and 3:30-7 pm) will be in effect. The work will require a reduction in peak-hour service and suspension of Baby Bullet service. The current 104 weekday trains will be reduced to 88. Weekday middays, evenings, and weekend service remain unchanged. For more information on service changes, please visit www.caltrain.com/March2022.

Trains are single-tracking through Broadway, Burlingame, San Mateo, Hayward Park, and Hillsdale stations for three weeks affecting passenger boarding. Riders using those stations should be sure to pay attention to signage and announcements to make sure they are waiting at the correct platform at the station.

PROJECT OVERVIEW

Over the last decade, Caltrain has experienced a substantial increase in ridership and anticipates further increases in ridership demand as the Bay Area's population grows. Caltrain Electrification, scheduled to be operational by 2024, will electrify and upgrade the performance, operating efficiency, capacity, safety, and reliability of Caltrain's commuter rail service.


Caltrain electrification is a key component of the Caltrain Modernization Program and consists of replacing diesel-hauled with an electric train system for services between Fourth and King Street Station in San Francisco and the Tamien Station in San Jose. The project will include the installation of new electrical infrastructure and the purchase of electric trains.

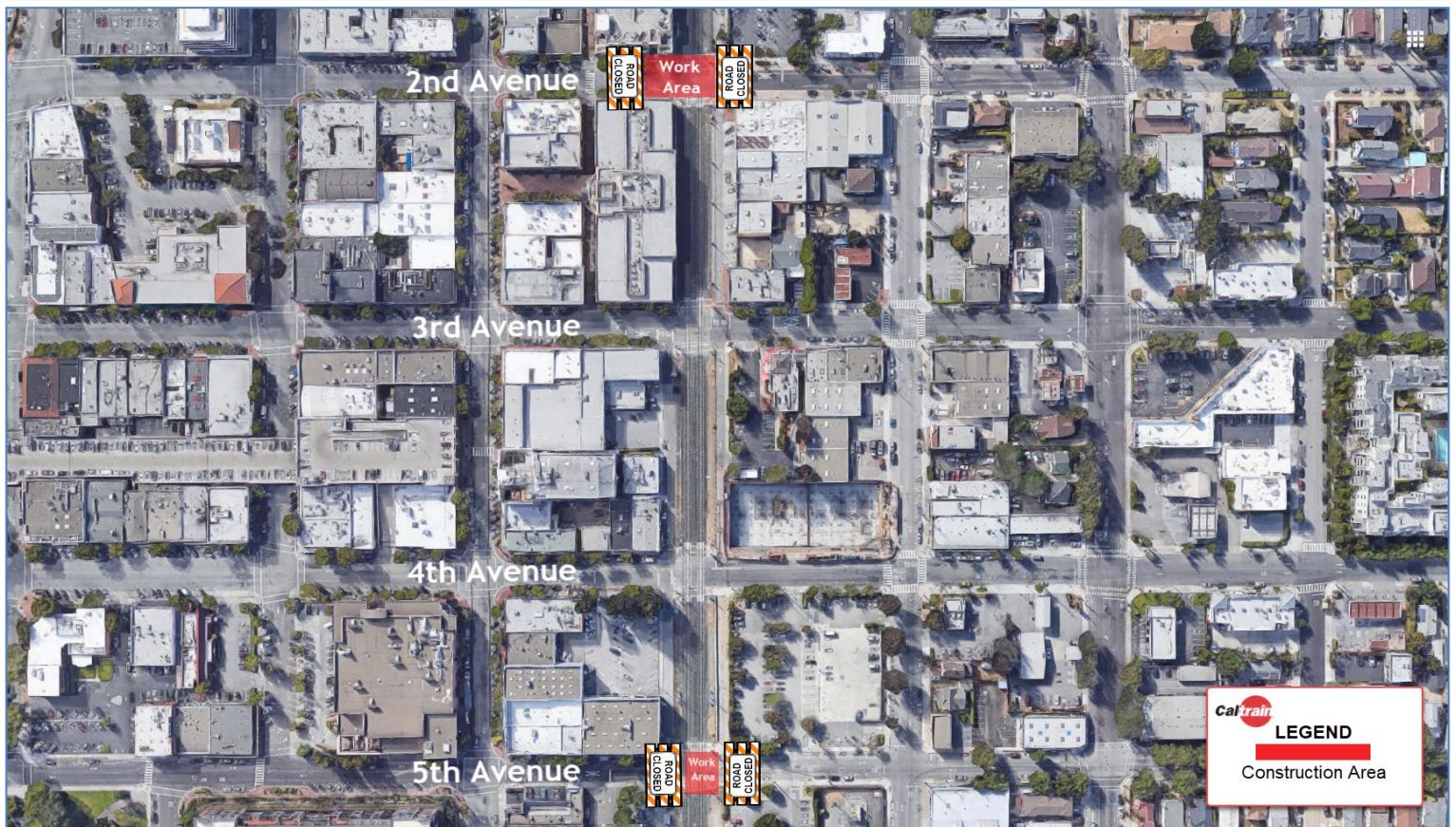
